❖ **“Joint Combat Operations Model and Theory”**

SUBJECT: Joint Major Combat Operations, past and present.

METHOD: Statistical model development and testing; Thurstone Judgmental Development.

OUTPUT: Set of close-ended questions for use by Joint Forces Commander or Combatant Commander for use in final stages of Collaborative Planning to reassure Commander of probability of success in major combat operations; reports, articles, book on the development and testing of the model.

REQUIREMENTS: Continual updating to reinforce validity of model; validation through interviews with unified command planning community.
