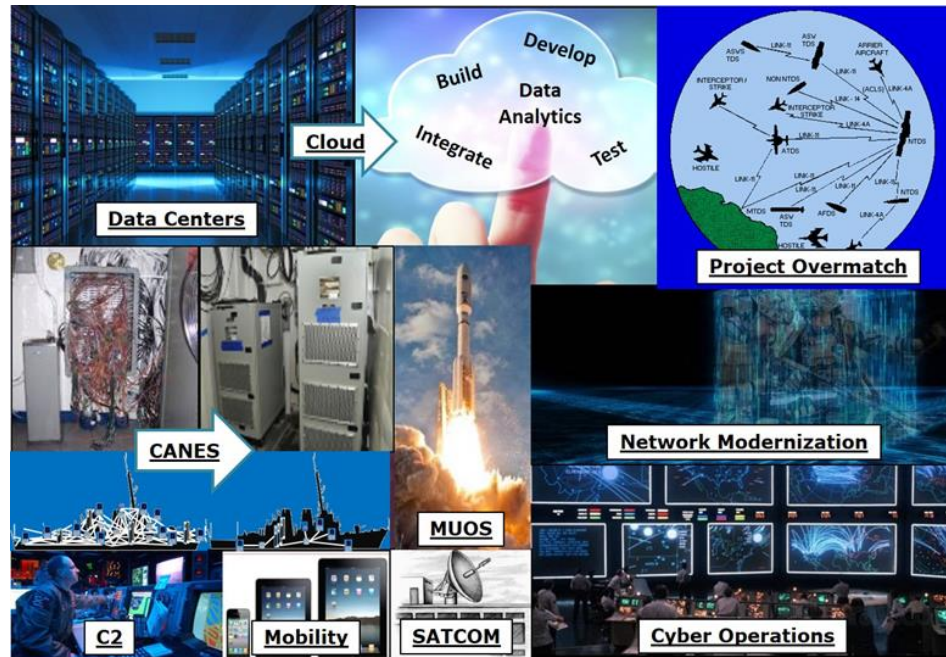

DON CIO Aaron Weis: “Now that we know that we can fly, you know, we don’t settle for ground travel.”



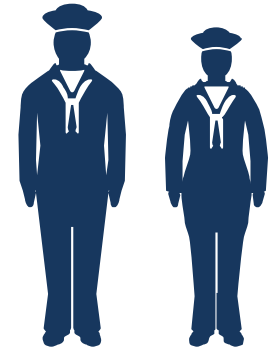
