- 1. <u>Purpose.</u> To promulgate the mandatory individual training topics and due dates for all Navy staff, faculty members, and students assigned to the Naval Postgraduate School (NPS) for Fiscal Year (FY) 2021 per references (a) through (c).
- 2. <u>Action.</u> All Navy servicemembers, civilian employees, and full-time contractor personnel shall familiarize themselves with enclosure (1) and complete the individual training topics listed by the end of the month assigned. In addition to the training listed in enclosure (1),
- a. Completion of additional supervisor training is required for all civilian and military members who supervise civilian employees.
- b. Completion of additional security refresher training is required for all personnel with access to classified materials.
- c. Completion of additional ethics training is required for personnel required to file Office of Government Ethics Form 450.
