The Army Director, Acquisition Career Management (DACM) Office is pleased to announce the offering of the Naval Postgraduate School Systems and Program Management Non-Resident Master's Degree Program (NPS-MSSPM) education opportunity. The Army DACM Office is the sponsor of the NPS-MSSPM program and will fund the cost of books and tuition. Graduation and travel expenses are not included in the funding.

The NPS-MSSPM is a degree program conducted via distant learning. Students take two distance learning courses per quarter for eight consecutive quarters. All classes use an internet tool called, "ZoomforGov (ZfG)." ZfG uses Voice over Internet Protocol (VoIP) technology to send both video and audio over the internet to any computer logged into the course site. The NPS-MSSPM is delivered exclusively through ZfG sessions on Tuesdays and Thursdays 0800 – 1100 (Pacific Time). Students will need Internet access, a personal computer (PC) microphone, and a PC camera (optional) to use ZfG. There is no special software required for ZfG. Students can connect directly via their internet browser.

Program Information:

The NPS-MSSPM 2-year program is designed for Department of Defense (DoD) and other federal agencies to obtain an acquisition defense-focused advanced degree in a distance learning format.

The NPS-MSSPM is an interdisciplinary program combining systems engineering with program management knowledge and skills. The program is intended to broaden the technical capabilities of the acquisition workforce who may have non-technical backgrounds, so they are able to successfully manage and lead programs/projects in support of the Defense Acquisition System. Students in this program learn the systems engineering process from establishing system requirements through test and evaluation. Simultaneously, students learn how to manage, schedule, and budget programs as well as work with DoD suppliers through contracts to meet program obligations.

Students who successfully complete the NPS-MSSPM program will earn a Master of Science in Systems Engineering Management and the following:

Reimbursement:

Reimbursement is required in connection with the NPS-MSSPM education training under the following situations:

- An “incomplete”, “failed”, or a grade less than a “B” in a course.
- “Drop” or “withdraw” from a course after the course start date.

Applicants:

Army acquisition workforce (AAW) civilians must meet both the NPS academic requirements, and the Army DACM Office eligibility requirements listed below to apply and be considered for funding sponsored by the Army DACM Office.

NPS Academic Requirement:

- Any undergraduate degree (BA, BS, other)
- Minimum undergraduate quality point rating of 2.2 or better

Army DACM Office Eligibility Requirements: Eligibility requirements below must be met at the time the application is submitted in CAPPMIS:

- Must be coded as “1 – Permanent – Tenure Group 1” in the Defense Civilian Personnel Data System*
- Must be a GS-11 through GS-15 or broadband/pay band equivalent
- Must meet certification level required for current Army acquisition position in any acquisition functional area (AFA) OR
- Must be within their certification grace period required for their current Army acquisition position in any AFA.
- Must have a Conditional Letter of Acceptance from NPS

*Per Section 1109, of the FY16 National Defense Authorization Act (NDAA) and Section 11.A.3.f, 82 of Federal Register 43339, eligibility to participate in NPS-MSSPM is extended to flexible length and renewable term technical appointment employees in the Department of Defense laboratories designated as Science and Technology Reinvention Laboratories (STRs). Term employees not appointed under Section 1109, FY16 NDAA are not eligible for NPS-MSSPM. Tenure status is indicated on the SF-50, Notification of Personnel Action, Block 24. To apply to the NPS-MSSPM, your supervisor must verify that you are an STRL employee appointed under Section 1109, FY16 NDAA. Supervisor must submit verification email to the Army DACM Office NPS-MSSPM Program Manager. STRL employees must meet all other NPS-MSSPM eligibility requirements.

How to Apply for NPS Admissions – Part 1:

- The NPS-MSSPM online application is a two-part process: Part 1 consists of applying directly to NPS website at https://nps.edu/web/dl/degProgs_MSSPM_nonRes. Once on the NPS website click the “Appl Now” link under “Quick Links” to the left of the screen and following the instructions for Army DACM Office applicants. Army DACM applicants must apply for 722 curricula, commencing Academic Year 2025, Quarter 1. Requests for officially sealed transcripts from all schools attended (undergrad/grad) must be sent directly to NPS.
- NPS application deadline is 6 May 2024. Official transcripts (sealed) from all undergraduate/graduate schools attended must be sent by mail or electronic transfer to the Admissions Office and received no later than 6 May 2024.

How to complete the Army DACM Office NPS-MSSPM Application – Part 2:

You can begin part 2 of the application process by logging into CAPPMS at <https://apps.asc.army.mil/camp/>. Click the AAPDS tab. Click “apply” next to the “NPS-MSSPM (722-251G) Announcement” to access the online Army DACM Office NPS-MSSPM application. A blue “apply” link will only be available to those AAW civilians who are eligible to apply to the program via the DACM announcement. A message will be displayed stating reason(s) why an applicant is not eligible to apply to the program. Please contact the DACM Office Program Manager at uhura.n.smith.civ@army.mil if your eligibility status is in error.

- **NPS-MSSPM Applicant Data:**

- ✓ Select “Masters” for the degree.

- ✓ Select “Naval Post Graduate School” for the school.

- ✓ Select “Systems and Program Management” for the major.

- ✓ A valid work number and email address are required on your application.

- **Verifications:** Check the small boxes next to “Applicant’s Email Address”, “Supervisor Information”, and ACRB in the application to certify your email address, supervisor’s information and ACRB are correct. If these boxes are not checked, you will receive an error message when you attempt to submit your application.

- **Acquisition Career Record Brief (ACRB):** Within CAPPMS, the latest version of the ACRB will automatically be uploaded into AAPDS online application. Ensure your ACRB is updated and correct prior to submitting your application. Applicants may update and correct specific fields of their ACRB using the edit functions within CAPPMS. For the areas on the ACRB that cannot be changed by the applicant, please request assistance using our Army DACM Office online help request at <https://apps.asc.army.mil/camp/index.cfm?fuseaction=support.help>.

Applicants will want to pay particular attention to the training, education, and assignment history sections of the ACRB, ensuring that the information is accurate. The training section should only reflect top level relevant training completed.

- **Senior Rater Potential Evaluation (SRPE).** The SRPE is a critical piece of the application. In accordance with DACM SRPE Policy at https://apps.asc.army.mil/camp/apps/cappmis/modules/srpe/assets/documents/SRPE_Policy_JUL2020.pdf and the SRPE Guidance at https://apps.asc.army.mil/camp/apps/cappmis/modules/srpe/assets/documents/SRPE_Guidance_JUL2020.pdf, both dated 1 July 2020, the applicant's SRPE must be completed by both the Rater and Senior Rater (SR). The SR must be a supervisor and senior in grade/organizational position to the rated employee.
 - ✓ The SRPE must have an ending date (the "thru" date) within one year of the closing date of the announcement. The SRPE must be completed and generated using CAPP MIS. Of note, the SR should not use bullet comments; rather, narrative comments to support the overall rating are highly suggested. Senior Raters should view a SRPE as the equivalent to a "complete the record OER" and should provide supporting comments accordingly.
 - ✓ For additional information on the completion of the SRPE, Senior Raters should refer to the USAASC policy web page under the SRPE section. The link to the new SRPE form (AAC Form 1) and instructions are also located on the USAASC policy web page under the SRPE section. Applicants should print and retain a signed copy of the SRPE for their records.
 - ✓ Instructions/tutorials are available in CAPP MIS to assist the rater and Senior Rater in completing the SRPE. The SRPE form must be completed in CAPP MIS by your supervisor and senior rater and will automatically upload into your online application. The SRPE must be completed/finalized in CAPP MIS no later than the closing date posted in this announcement. Applicants should print and retain a signed copy of the SRPE for their records.
 - ✓ Failure to have a completed/finalized SRPE in CAPP MIS prior to the announcement closing date will result in the applicant being declared ineligible. The application will be denied and will not go forward to the Board for evaluation.
- **Command Endorsement (PDF file):** Your command must endorse your participation in the NPS-MSSPM program by preparing a memorandum in accordance with Army Regulation 25-50.

 - ✓ Identify how post utilization training will be utilized in the command upon completion of the program and;
 - ✓ Include at least one potential thesis/capstone project research topic for the applicant to address while in school that has benefit to your organization and;
 - ✓ Be digitally signed and dated by the required completing official and;
 - ✓ Applicant uploads completed Command Endorsement into CAPPMS/AAPDS
- **Supervisor Endorsement (PDF file):** The Supervisor Endorsement Memorandum is limited to one page and **must** adhere to the guidelines below:
 - ✓ Be from either your 1st or 2nd level supervisor. The supervisor's name must match the supervisor's name in CAPPMS and;
 - ✓ Be on organizational letterhead and;
 - ✓ Be addressed to the following (but DO NOT MAIL): Army Director, Acquisition Career Management Office, Bldg 201, Suite 101, 9900 Belvoir Road, Fort Belvoir, VA 22060 and;
 - ✓ Be unique to the specific applicant and;
 - ✓ Directly comment on the applicant's current performance and;
 - ✓ List strengths of the applicant and;
 - ✓ Include the following statement:
 - "I approve [insert applicant's name] to participate in the NPS-MSSPM program during duty time every Tuesday and Thursday from 0800 to 1100, (Pacific Time) whenever class is in session for the duration of the 24-month program, starting the week of 30 SEP 2024 and ending 25 SEP 2026."* and;
 - ✓ Be digitally signed by the required completing official and;
 - ✓ Applicant uploads completed Supervisor Endorsement into CAPPMS/AAPDS
- **Resume (PDF file):** Upload your resume using the resume format at <https://asc.army.mil/web/wp-content/uploads/2021/03/RESUME-FORMAT.pdf>. Resumes may not exceed 4 pages and must be submitted in a .pdf format. This is the applicant's opportunity to highlight educational achievements, work experiences, skills, and accomplishments, which are key indicators to the preparation for and success as an acquisition professional. Applicants should also highlight their qualities and strengths instead of listing responsibilities. Ensure experience descriptions and dates match those in the ACRB.
- **Statement of Interest (PDF file):** The applicant must create a personal "Statement of Interest" describing why you want to participate in the NPS-MSSPM program. Please complete the statement of interest in accordance with Army Regulation 25-50.

The Statement of Interest is limited to one page and must adhere to all guidelines below:

 - ✓ Applicant must upload completed Statement of Interest into CAPPMS/AAPDS
- **NPS Conditional Letter of Acceptance:** Applicants must upload into AAPDS a copy of the NPS "Conditional Letter of Acceptance" obtained from Heather Hahn at NPS. NPS online admissions application must be completed no later than 6 May 2024. Individuals who obtained letters of conditional acceptance for prior year admission can submit their existing letters of conditional acceptance for the current NPS-MSSPM Announcement. You do not need an updated conditional acceptance letter from NPS. You must meet all NPS academic requirements and Army DACM eligibility requirements to participate in the program if you should be selected for participation by the Army DACM Office.

- **Service Agreement (SA):** The Army Director, Acquisition Career Management Office requires that Army Acquisition Workforce (AAW) civilians complete a SA as part of their application process. Supervisors will ensure the AAW civilian is informed in advance of this requirement. The period of obligated service will be 24 months from the completion date of the program.

CAPP MIS will automatically generate all courses from the IDP into the online application only after the applicant correctly completed the above steps.

Unofficial Copy of NPS Transcript: Participants are required to provide an unofficial copy of their NPS transcript to the Army DACM Office NPS-MSSPM Program Manager via email showing grades for completed courses no later than 30 days after each course completion date.

Graduation/Completion of Program: Graduates are required to upload an unofficial .PDF, .JPEG, .PNG, or .DOCX copy of their NPS transcript in AAPDS/Student Module. No further action is required. The Army DACM Office NPS-MSSPM Program Manager will review and add the educational credits to the education portion (Section VII) of the ACRB. Please contact Uhura N. Selection Process:

The Army DACM Office NPS-MSSPM Program Manager will review all applications that have been submitted in CAPPMS. Successfully completed applications will be forwarded to the Review Board for evaluation.

The Army DACM Office NPS-MSSPM Program Manager will compile data from the Board results, brief, and provide a recommendation to the Army DACM. Approved results will be provided to the Army Acquisition workforce no later than the board review date posted in this announcement. The Army DACM is the final approval authority of selection to participate in the NPS-MSSPM Program.

1. The FY25 off campus tuition price for **Full Partner** enrollment seats entering the two-year, eight quarter (two courses per quarter) distributed learning part-time **Systems and Program Management (MSSPM) Non-Residence Distance Learning Master’s Degree Program (Class 722-251G)** is \$2200 per course (\$35,200 for degree) for military, federal government civilian employees and defense contractors, payable in full by FY, quarterly installments or as negotiated with the program manager. Qualified active duty Naval and Marine Corps Officers may be eligible for NPS mission funding. Tuition does not include textbooks. If requested, NPS can provide textbooks for an additional \$250 fixed fee per course per student. Tuition price with books is \$2450 per course (\$39,200 for degree).

Courses are delivered over the Internet using ZoomforGov (ZfG), a web-conferencing tool. Each course also has a site on SAKAI, the NPS course management system. To participate, students and/or local commands need high speed Internet access, a PC microphone and PC camera (optional). No special software is required to use ZfG. Students can access a session link directly from their internet browser.

2. Funding documents issued to the Naval Postgraduate School should be addressed to President, Code 21, Naval Postgraduate School, Monterey, CA 93943 and must be in accordance with reference (a). Funding documents should be emailed to and tuition@nps.edu and copy GEACBFM@nps.edu. The funding documents should include program title **MSSSPM Non-Resident Master’s Degree Program** and also list the technical contact as Dr. Wally Owen (831) 402-6086, wowen@nps.edu and the business financial manager contact as Ms. Yves Cameron (831) 656-3970, yvcamero@nps.edu. Expiration date for all funding documents should be 30 September unless negotiated with Dr. Wally Owen.

3. NPS Fall quarter begins in September. US government activities using appropriated funds must pay for that quarter as a “Project Order” with previous FY dollars since the course is non-severable. For this to occur, the funding document must annotate in the text an expiration date of 31 December so that the funds can be deposited in an appropriate FY rollover account. All other payments can be issued as an “Economy Act” with an expiration date of 30 September. All sponsors must have an agreement in place with NPS (Form 7600A for U.S. Navy or DD1144 all others) before a student can be enrolled in a NPS program and before funding can be accepted.
